# CONDITIONS OF SALE

## 1. RESERVE PRICE AND BIDDING AT AUCTION

- 1.2 Subject to the provisions of Clause 5 below the highest bidder for the Property described in the Proclamation of Sale if so allowed by the Auctioneer shall be the Purchaser ("Purchaser") thereof and the Auctioneer shall have the right to reject any bid. ## 3. AUTHORITY TO ACT/BID

In the event that the Assignee/Lender is the successful bidder and so declared by the Auctioneer, the Assignee/Lender shall have the liberty to set off the purchase price against the amount due and owing by the Assignor(s)/Borrower(s) under the **Facility Agreement and Deed of Assignment both dated 08<sup>th</sup> day of April, 2013** and all costs and expenses of, in connection with and resulting from the sale;
- 5.2 Right to withdraw Sale
